AN ORDINANCE PERTAINING TO WATER RATES

WHEREAS, Otter Lake Water Commission, ADGPTV (the "Commission") adopts ordinances from time to time establishing rates charged by the Commission for water it provides to its customers;

WHEREAS, by ordinance effective December 1, 2018, the Commission established specific fixed rates for wholesale member municipalities and customers and retail customers, including those rates for the first one thousand (1,000) gallons for those retail customers with water meters up to and including three inches (3") in size;

WHEREAS, by ordinance effective March 1, 2022, the Commission established specific fixed rates for retail customers with water meters larger than three inches (3") in size for the first one thousand (1,000) gallons;

WHEREAS, by ordinance effective March 1, 2022, the Commission imposed an annual increase of three percent (3%) on the rates for wholesale member municipalities and the retail rates for usage beyond the first one thousand (1,000) gallons but retained the rate for wholesale customers other than member municipalities at member municipality rate plus five percent (5%);

WHEREAS, the Commission has undertaken repairs and improvements to its water main near and along Illinois Route 104, and the Commission finds it reasonable and necessary to increase its retail and wholesale rates by forty-three cents (\$0.43) per one thousand (1,000) gallons of usage in addition to the aforementioned annual increases in order to finance the construction project and the associated loan.

BE IT ORDAINED BY THE OTTER LAKE WATER COMMISSION, ADGPTV, AS FOLLOWS:

SECTION 1: IMPOSITION OF RATES

Current Water Rates charged by the Commission to its customers shall henceforth have an annual 3% increase on its wholesale member municipality rates and its retail rates after the first 1,000 gallons used. The rate for wholesale customers other than member municipalities will remain to be member municipality rates plus 5%. The annual rate increases shall go into effect on March 1st of each calendar year, beginning March 1st, 2025, ending and to be reevaluated after the final annual increase on March 1, 2026. Current Water Rates are as follows:

- A. Wholesale, member municipalities:\$5.73 per thousand gallons, effective March 1, 2025
- B. Wholesale customers other than member municipalities:\$6.02 per thousand gallons, effective March 1, 2025

C. Retail Customers:

1. For the first 1,000 gallons or any portion thereof in a monthly billing period as of March 1, 2025:

5/8 inch meter -	\$16.99 per month
1 inch meter -	\$22.49 per month
1.5 inch meter -	\$30.74 per month
2 inch meter -	\$33.49 per month
3 inch meter -	\$42.29 per month
4 inch meter -	\$70.00 per month

6 inch meter -

\$80.00 per month

8 inch meter -

\$90.00 per month

10 inch meter -

\$100.00 per month

- 2. For use in excess of 1,000 gallons in a monthly billing period:
- \$8.15 per 1,000 gallons, effective March 1, 2025
- 3. For fire lines: \$5.00 per month per inch of exterior diameter of the line.

SECTION 2: ADDITIONAL RATE

In addition to the Current Water Rates and annual increases provided for in Section 1 of this Ordinance, there shall be the following additional charge:

- A. All Wholesale Customers: forty-three cents (\$0.43) per one thousand (1,000) gallons used.
- B. All Retail Customers: forty-three cents (\$0.43) per one thousand (1,000) gallons used in excess of the first one thousand (1,000) gallons for all retail customers.
- C. Duration: This Additional Rate shall remain in effect until the Commission amends or repeals this Additional Rate.
